

**THE KUSKOKWIM CORPORATION
CLASS “B” (CHILD’S) STOCK
INFORMATION, INSTRUCTIONS, AND APPLICATIONS**

BACKGROUND

At the 1994 Annual Meeting of Kuskokwim Corporation, Shareholders authorized Kuskokwim to enroll up to 2,000 eligible applicants for Class “B” stock. The official Terms and conditions for issuing and receiving Class “B” stock are set forth in TKC’s Articles of incorporation and board resolution. These control if there is any conflict with this explanation. These shares will be issued in the order of applications received.

ELIGIBILITY

Class “B” Settlement Common Stock will be made available without charge to individuals Who, upon application to the Corporation, are determined to be:

- A Native or descendant of a Native as defined by ANCSA 1, and
- Born after December 18, 1971; and
- The child, by blood or an adoption, of an original TKC enrollee; or of a Class “B” shareholder or person eligible to be a Class “B” shareholder.

DIVIDENDS AND DISTRIBUTIONS

The Class “B” stock will receive the same dividends and distributions from TKC as Class “A” Stock. There will be no payments for past dividends or distributions.

SHARES TO BE ISSUED

A total of 100 shares will be issued to each eligible applicant upon approval.

The terms “Native” and descendant of a Native” are both defined in ANCSA. Generally a “Native” means a citizen of the United States who is a person of one-fourth degree or more Alaska Indian, Eskimo, or Aleut blood, or combination thereof.

“Descendant of a Native” means the lineal descendant of a Native or in certain cases a persons adopted by a Native or descendent of a Native.

TERMS, CONDITIONS AND RESTRICTIONS

Class “B” stock will have the same ANCSA restrictions as the Class “A” stock. For example, the stock cannot be sold, pledged, assigned or taken away by creditors. Like Class “A” stock, Class “B” stock will not have preemptive rights to purchase additional stock in TKC.

Acceptance of Class “B” stock constitutes acceptance of the following terms and conditions by the shareholder and their custodian and such future conditions, if any, as the TKC Board of Directors may by resolution approve:

- The Class “B” stock shall have a right to vote.
- The Class “B” stock shall be life estate stock which means it only lasts as long as the shareholder owning the stock is alive. After the death of that shareholder the stock is cancelled without compensation to the heirs.
- The Class “B” stock, inchoate rights thereto, and the right to receive dividends and distributions may not be sold, pledged, assigned in present or future, or otherwise transferred, except as other-wise allowed under ANCSA.
- Class “B” stock will be cancelled by TKC if it is later determined that the recipient was not eligible to receive the stock.

ACKNOWLEDGEMENT OF APPLICATION

You will be notified by mail when the application(s) from your household has been received. This Receipt IS NOT a guarantee of eligibility to receive Class “B” stock. How soon you get this Notice will depend on the volume of applications received. If you do not have this receipt within Forty five (45) days from the date you mailed in your application, please contact our Shareholder Relations Department.

Information required by Vital Statistics is: the individual's name at birth, date and place of birth, and the full name(s) of parent(s). The certified copy of the birth certificate will be sent about three weeks after they receive the request. If the individual was born at home, is under one year of age, and the birth was not registered, it will take from six to eight weeks to obtain a copy of the birth certificate.

In Anchorage you can go to Vital Statistics in the Frontier Building at 3601 C Street, Suite 128 between the hours of 8 am to 4 pm

If the applicant was not born in the State of Alaska, contact Vital Statistics in the State where the individual was born. Your local library can help you find the right address, or you can call the Alaska Bureau of Vital Statistics.

If you were born in the State of Alaska, are over the age of 18, believe you were adopted and want information on your biological parents you may contact Vital Statistics.

Children adopted by parents who are not TKC shareholders are eligible as long as the child meets the eligibility criteria (see ELIGIBILITY, page 1).

APPLICATION INSTRUCTIONS

IF APPLICANT IS UNDER AGE 18, AN ADULT MUST COMPLETE THE APPLICATION.

LINE 1. Child's Social Security Number. Social Security number is required for identification and other official purposes.

LINE 2. Child's First and Middle Name. Enter the child's (Class "B" application's) legal first and middle name. Do not use any nicknames: if your name is Robert L. Doe, do not enter your name as Bob L. Doe.

LINE 3. Child's Last Name. Enter the child's (Class "B" applicant's) legal last name, include Suffix (Jr., Sr., II., etc.) that is used today.

LINE 4. Child's Mailing Address. Enter the current mailing address. The Shareholder Relations Department must be notified in writing of any changes to the mailing address.

LINE 5. Home Phone Number. Enter the home phone number. If you do not have a phone, enter N/A. If you can give a message phone number, please do so. This will assist us, should we need further information regarding your application.

LINE 6. Daytime Phone Numbers. Enter a work or message phone number. If a message number is given, please write down whom we should ask for.

LINE 7. Is the Child already a TKC shareholder? Mark the appropriate box.

LINE 8. Is the Child adopted? If “YES”, complete questions 19 and 20 on the back of the form and include a copy of the adoption papers.

LINE 9. Sex. Indicate child’s gender.

LINE 10. Date of Birth. Use two (2) numbers for each section of the birth date. For example, if the birth date is June 2, 1973, you should enter the date as “06/02/73.

LINE 11. Proof of Eligibility. An applicant must provide proof of date of birth and their relationship to an original TKC shareholder. Acceptable proof is a certified birth Certificate or adoption papers. If you mark other and include a document other than Certified birth certificate or adoption papers, we will accept them on a case-by-case Basis. If a legal document shows proof of the child’s parents. This is the main reason we cannot accept a birth card since it doesn’t show who the parents are.

In order to determine whether an applicant is an Alaska Native or a descendent of an Alaska Native, it is important to have information regarding biological parents. If known. If you don’t know who the biological parents are, on a separate sheet list as many blood relatives as you know. Include with the application

LINE 12a. Biological Mother’s Name. Please provide birth mothers full first, middle initial, Last, and maiden name. If unknown, mark “Unknown”.

LINE 12b. Biological Mother’s Date of Birth. Indicate birth mother’s date of birth (optional).

LINE 12c. Biological Mother an original Kuskokwim ANCSA Shareholder? Mark the appropriate Box.

LINE 13a. Biological Father’s Name. Please provide birth fathers full first, middle initial, and last name. If unknown, mark “Unknown”.

LINE 13b. Biological Father’s Date of Birth. Indicate birth father’s date of birth (optional). Use two (2) numbers for each section of his birth date.

LINE 13c. Biological Father an original Kuskokwim ANCSA Shareholder? Mark the appropriate Box.

IF THE APPLICANT IS UNDER AGE 18, COMPLETE QUESTIONS 14-18

IF THE APPLICANT IS OVER AGE 18, CONTINUE TO LINE 19

LINE 14. Person Making Application for a Minor Child: An adult relative or guardian may complete an application for a Minor Child, such as the grandparents, brother, sister, Aunt, or Uncle. We must know who to correspond with when following up with this application request. If completing an application for a Minor Child List your first name, middle initial and last name.

LINE 15. Mailing Address. Enter the current mailing address of person completing the application.

LINE 16. Is child living with you? Please indicate whether the child is living with you. If the Child is not, who are they currently living with?

LINE 17. Are you the child's legal custodian? Mark "YES" or "NO". If No, indicate who is, if known.

LINE 18. Your Relationship to the Child. Indicate your relationship to the child on whose behalf you are you submitting this application.

IF YOU ANSWERED YES TO QUESTION 10, PLEASE COMPLETE QUESTIONS 19 AND 20.

LINE 19a. Adopted Mother's Name. Please provide adopted mothers full first, middle initial, last, and maiden name.

LINE 19b. Adopted Mother's Date of Birth. Indicate adopted mother's date of birth (optional). Use two (2) numbers for each section of her birth date.

LINE 20a. Adopted Father's Name. Please provide adopted father's full first, middle initial, and last name.

LINE 20b. Adopted Father's Date of Birth. Indicate adopted father's date of birth (optional). Use two (2) numbers for each section of his birth date.

LINE 20c. Adopted Father an original Kuskokwim ANCSA Enrollee? Mark the appropriate box.

LINE 21. Terms, Condition, and Restrictions. You must read these requirements.

LINE 22. Certification and Signature. Please read the certification, sign and date the application. When signing you are certifying that you understand this information and accept the terms, conditions, and restrictions.
