### Percentage Method for Dividing among Heirs Equally

If you would like to divide your shares as equally as possible among the heirs you've listed, you can use the percentage methods below. This table does not mean that you must divide your shares equally, it simply shows what the percentages would be if you'd like to divide your shares as equally as possible. For example, we have seen wills where the shareholder wanted one heir to receive 90% and the other heir to receive 10%, which is perfectly fine. The amount you want an heir to receive is up to you.

**1 heir (to inherit all)**

100%

**2 heirs (to divide equally)**

50%, 50%

**3 heirs (to divide as equally as possible)**

33%, 33%, 34%

**4 heirs (to divide equally)**

25%, 25%, 25%, 25%

**5 heirs (to divide equally)**
